Summary

Survey of commuters using 95 Express Lanes between Downtown Miami and Golden Glades Interchange in May 2009. 9,156 respondents answered questions via an online survey referring to their recent trips on the chosen I-95 segment. Questions were asked pertaining to their trip purpose, frequency, and mode. In addition, respondents were asked whether they had used I-95 before the installation of 2 HOT lanes, the reasons why/why not, and whether they used in afterwards. Respondents are also asked their satisfaction with the upgrade, as well as their perceptions of safety and success of the project/I-95. Data surrounding the respondents' age, race/ethnicity, and income is also collected. The final sample size included 9,156 individuals who completed the study.
